For a Zoning Map Amendment to change the zoning of a property located south of Lafayette Road and west of Industrial Parkway with Parcel Number 028-19C-17-041 from I-1 (Industrial) to R-3 (High Density Urban Residential), to develop the site for an extension of the existing mobile home park to the north.

Mr. Dutton stated that I-1 is an industrial district with uses such as manufacturing, warehousing and things of that nature and R-3 is a residential district which allows single family homes with other uses and conditionally allows a mobile home park which would need to be approved by the planning commission if this goes forward.

Proposal went to Planning Commission and approval was recommended.

Jim Hauk spoke in favor of zoning amendment. Stated they are addressing the concern of noise. Fencing will be provided for sound barrier for any noise coming from factories.

Today is National Law Enforcement Appreciation Day.

On Wednesday, January 4, at 7:45 a.m. I was monitoring police radio and Sgt. Sloan stopped a vehicle occupied by 3 Guatemalans, none of whom spoke English as he was requesting a police

officer from another agency that spoke Spanish. I radioed him that Miles Reed from Medina TV can assist if no officer is available as he can speak several languages including Spanish. Miles responded and assisted. Using available staffing and resources to best serve our community. Thanks Miles!

Annual Martin Luther King, Jr. celebration this year will be Monday, January 16, 2023 at 7 p.m. at Medina United Methodist Church,4747 Foote Rd., Medina. Featured speaker will be Bishop Kenneth W. Paramore of Christ Centered Church in Akron/Youngstown. All are welcome! Mayor Hanwell welcomed United Way of Summit and Medina Counties to talk briefly about a new program we are collaborating with them on for financial coaching to our constituents. Paul Khacherian, Director of Community Impact, UWSM and team will introduce themselves.

Keith Dirham, Finance Director, stated the City of Medina does have a municipal income tax, we contract with RITA. Please remember to file if you are a resident of the city.

Mr. Dirham stated this is the annual authorization to purchase jet fuel, the request is for \$135,000.00 for the year and is subject to change with fuel prices. The reason for the Emergency Clause is we need to purchase jet fuel within that time and could not have passed this ordinance prior to 2023. Formal approval has to be in 2023 for the purchase order. An Ordinance authorizing the increase off the expenditure to Mason Custom Builders for the Service Department. Mr. Shields moved for the adoption of Ordinance/Resolution No. 002-23, seconded by Mr. Simpson. Mr. Shields moved that the emergency clause be added to

Project was for bathroom renovations, and there were some unforeseen issues with materials and locating them. If approved tonight this won't go into effect for 30 more days and that is why the emergency clause is requested so that the contractors can be paid. An Ordinance authorizing the payment to Software Solutions Inc. (SSI) for annual support services for the City's VIP Professional Accounting System. Mr. Shields moved for the adoption of Ordinance/Resolution No. 003-23, seconded by Mr. Simpson. Mr. Dirham stated this is the annual software for the Finance Department and Utility Billing. The roll was called and Ordinance/Resolution No. 003-23 passed by the yea votes of J. Hazeltine, B. Lamb, P. Rose, J. Shields, D. Simpson, J. Coyne, and R. Haire.

Res. 004-23

A Resolution requesting the County Auditor to make tax advances during the year 2023 pursuant to Ohio Revised Code Section 321.34. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 004-23, seconded by Mr. Simpson. Mr. Dirham stated they have to request these advances every year, if they do not request the advances they will only receive property tax from the county at the final settlement. It is required to make the requests in the year that they are requesting it for and this is the earliest meeting and that is why the emergency is needed. The roll was called on adding the emergency clause and was approved by the yea votes of B. Lamb, P. Rose, J. Shields, D. Simpson, J. Coyne, R. Haire and J. Hazeltine. The roll was called and Ordinance/Resolution No. 004-23 passed by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, R. Haire, J. Hazeltine, and B. Lamb.

Ord. 005-23

An Ordinance authorizing the Job Creation Grant Agreement for Agrati, Inc. Mr. Shields moved for the adoption of Ordinance/Resolution No. 005-23, seconded by Mr. Simpson. Kimberly Marshall stated this is for an expansion of their business. The Business Development Committee met with the company and approved the project. The Law Director has reviewed the agreement and has approve it. When passed through Finance it was subject to company actually selecting the City of Medina for the project and Kimberly would like to do that again. As a reminder to council and public that the Job Creation Grants are funded from non-income tax generated revenue. The roll was called and Ordinance/Resolution No. 005-23 passed contingent upon the selection of the City of Medina. The roll was called and passed by the yea votes of J. Shields, D. Simpson, J. Coyne, R. Haire, J. Hazeltine, B. Lamb, and P. Rose.

Ord, 006-23

An Ordinance accepting a Dedication Plat for a Public Alley. Mr. Shields moved for the adoption of Ordinance/Resolution No. 006-23, seconded by Mr. Simpson. Mr. Patton stated the city owns a parcel of land about 35 feet wide and runs north from West Liberty Street on the West side along the west side of Sully's, it provides access to the City Hall Parking Deck. By dedicating this it will become a public alley. They will use 108 Funds to construct and maintain it. The roll was called and Ordinance/Resolution No. 006-23 passed by the yea votes of D. Simpson, J. Coyne, R. Haire, J. Hazeltine, B. Lamb, P. Rose, and J. Shields.

Ord. 007-23

An Ordinance amending Section 943.02 of the Codified Ordinances of the City of Medina, Ohio relative to the General Regulations for the Spring Grove Cemetery. Mr. Shields moved for the adoption of Ordinance/Resolution No. 007-23, seconded by Mr. Simpson. Mr. Wehrley stated in order to reduce their liability at Spring Grove Cemetery they are requesting to add a rule to their general regulations prohibiting swimming, ice skating and fishing in ponds, or pools of water at the cemetery. Cemetery Commission was in favor of this rule change. The roll was called and Ordinance/Resolution No. 007-23 passed by the yea votes of J. Coyne, R. Haire, J. Hazeltine, B. Lamb, P. Rose, J. Shields, and D. Simpson.

Ord. 008-23

An Ordinance amending Section V, VI and VII of the Civil Service Rules and Regulations of the City of Medina relative to Lateral Entry of Patrol Officers. Mr. Shields moved for the adoption of Ordinance/Resolution No. 008-23, seconded by Mr. Simpson. Chief Kinney stated a lateral entry program for the Police Department permits them to bring in officers from other departments who have at least one-year fulltime experience and expedite that hiring process. These changes were approved by the Civil Service Commission in December as well as the approval of the Law Director. Emergency is requested due to three openings that they need to fill as soon as possible. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 008-23, seconded by Mr. Simpson. The roll was called on adding the emergency clause and was approved by the yea votes of R. Haire, J. Hazeltine, B. Lamb, P. Rose, J. Shields, D. Simpson, and J. Coyne. The roll was called and Ordinance/Resolution No. 008-23 passed by the yea votes of J. Hazeltine, B. Lamb, P. Rose, J. Shields, D. Simpson, J. Coyne, and R. Haire.

Ord. 009-23

An Ordinance authorizing the Mayor to execute a contract with EnviroScience, Inc. for site investigation, design, permitting and construction oversite services as part of the Rocky River Stabilization Project at Huffman Cunningham Park. Mr. Shields moved for the adoption of Ordinance/Resolution No. 009-23, seconded by Mr. Simpson. Mr. Wehrley stated this is to enter into contract with a design consultant to address approximately 315 linear feet of river bank erosion at Huffman Cunningham Park. The project is around \$200,000.00 excluding the design costs. Requesting to use American Rescue Plan Act Funds for this project. The roll was called and Ordinance/Resolution No. 009-23 passed by the yea votes of B. Lamb, P. Rose, J. Shields, D. Simpson, J. Coyne, R. Haire and J. Hazeltine.

Ord. 010-23

An Ordinance amending Sections 31.05 and 31.07 of the Salaries and Benefits Code of the City of Medina, Ohio relative to the reorganization of the Parks and Recreation Department and the Recreation Center, and accepting various new and revised job descriptions. Mr. Shields moved for the adoption of Ordinance/Resolution No. 010-23, seconded by Mr. Simpson. Mr. Wehrley stated with combining the Parks and Recreation and the Rec Center Departments we need to accept new job descriptions for the Director of Parks, Recreation, Cemetery, and Forestry as well as a revised job description for the Recreation Center Superintendent and accept the job description for the Office Administrator and accept new job description for part-time office assistant. The roll was called and Ordinance/Resolution No. 010-23 passed by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, R. Haire, J. Hazeltine, and B. Lamb.

Ord. 011-23

An Ordinance authorizing an expenditure not to exceed \$45,000.00 to Baker Dublikar Wiley & Mathews for legal services for the Law Department. Mr. Shields moved for the adoption of Ordinance/Resolution No. 011-23, seconded by Mr. Simpson. Mr. Huber stated this law firm represents the City of Medina in a number of pieces of litigation that are pending. This is a purchase order that enables them to pay their legal fees. The roll was called and Ordinance/Resolution No. 011-23 passed by the yea votes of D. Simpson, J. Coyne, R. Haire, J. Hazeltine, B. Lamb, P. Rose, and J. Shields.

Ord. 012-23

An Ordinance amending Ordinance No. 168-22, passed September 12, 2022, relative to the expenditure to C & J Noble Construction for rehabilitation work at 172 Normandy Dr., Brunswick. Mr. Shields moved for the adoption of Ordinance/Resolution No. 012-23, seconded by Mr. Simpson. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 012-23, seconded by Mr. Simpson. Mr. Dutton stated this is related to a CHIP or rehabilitation project in Brunswick. The original amount was for \$72,000 and the increase is for \$4,000 increasing it to \$76,000. Emergency is needed due to contractors being paid since the work is completed and there was a delay due to the Holidays. The roll was called on adding the emergency clause and was approved by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, R. Haire, J. Hazeltine, and B. Lamb. The roll was called and Ordinance/Resolution No. 012-23 passed by the yea votes of J. Shields, D. Simpson, J. Coyne, R. Haire, J. Hazeltine, B. Lamb, and P. Rose.

Ord. 013-23

An Ordinance amending Ordinance No. 221-22, passed December 12, 2022. (Amendments to 2023 Budget) Mr. Shields moved for the adoption of Ordinance/Resolution No. 013-23, seconded by Mr. Simpson. Mr. Dirham stated this is the IT Fund budget and then there is a couple of pass throughs. The roll was called and Ordinance/Resolution No. 013-23 passed by the yea votes of J. Coyne, R. Haire, J. Hazeltine, B. Lamb, P. Rose, J. Shields, and D. Simpson.

ORDINANCE NO. 14-23

AN ORDINANCE AMENDING SECTION 31.15 AND 31.16 OF THE SALARIES AND BENEFITS CODE OF THE CITY OF MEDINA, OHIO RELATIVE TO GROUP HEALTHCARE AND TRAVEL AND EDUCATION.

WHEREAS: Section 31.16 of the Salaries and Benefits Code of the City of Medina, Ohio presently reads, in part, as follows pertaining to Group Healthcare:

The premiums for such plan shall be paid as follows:

- A. The City shall pay eighty percent (80%) of the premium costs, and the bargaining unit member shall pay twenty percent (20%) of the premium costs through payroll deduction. Employees who satisfy the wellness program obligations (see Attachment B) will be eligible for a "wellness" discount and will pay Fourteen percent (14%) as their premium contribution for 2023. In order to qualify for the reduced premiums in 2024 and 2025, the employee must satisfy the wellness components identified in Attachment B by September 1st of the preceding year.
- B. Effective January 1, 2024, if the City's insurance premium costs increase by one percent (1%) or more, employees satisfying the wellness program obligations shall pay fifteen percent (15%) of the premium costs through payroll deduction. Employees failing to satisfy the wellness program obligations will not be eligible for a "wellness" discount and will pay twenty percent (20%) as their premium contribution. The employee premium-contribution percentage shall remain at the 2023 percentage (14% or 20%) for 2024 if the City's insurance premium costs do not increase or increase by less than one percent (1%).
- C. Effective January 1, 2025, if the City's insurance premium costs increase by one percent (1%) or more, and the employees are still paying a fourteen percent (14%) premium contribution, the employees satisfying the wellness program obligations shall pay a premium contribution one percent (1%) higher than the 2023 rate (an increase to 15%) of the premium costs through payroll deduction. Employees failing to satisfy the wellness program obligations will not be eligible for a "wellness" discount and will pay twenty percent (20%) as their premium contribution. The employee premium contribution percentage shall remain at the 2024 percentage for 2025 if the City's insurance premium costs do not increase or increase by less than one percent (1%). (Ord. 93-20, 102-20)

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

SEC. 1: That Section 31.16 of the Salaries and Benefits Code of the City of Medina, Ohio pertaining to Group Healthcare shall be amended to read, in part, as follows:

- A. The City shall pay eighty percent (80%) of the premium costs, and the bargaining unit member shall pay twenty percent (20%) of the premium costs through payroll deduction. Employees who satisfy the wellness program obligations (see Attachment B) will be eligible for a "wellness" discount and will pay Fourteen percent (14%) as their premium contribution for 2023. In order to qualify for the reduced premiums in 2024 and 2025, the employee must satisfy the wellness components identified in Attachment B by September 1st of the preceding year.
- B. Effective January 1, 2024, if the City's insurance premium costs increase by one percent (1%) or more, employees satisfying the wellness program obligations shall pay fifteen percent (15%) of the premium costs through payroll deduction. Employees failing to satisfy the wellness program obligations will not be eligible for a "wellness" discount and will pay twenty percent (20%) as their premium contribution. The employee premium-contribution percentage shall remain at the 2023 percentage (14% or 20%) for 2024 if the City's insurance premium costs do not increase or increase by less than one percent (1%).
- C. Effective January 1, 2025, if the City's insurance premium costs increase by one percent (1%) or more, and the employees are still paying a fourteen percent (14%) premium contribution, the employees satisfying the wellness program obligations shall pay a premium contribution one percent (1%) higher than the 2023 rate (an increase to 15%) of the premium costs through payroll deduction. Employees failing to satisfy the wellness program obligations will not be eligible for a "wellness" discount and will pay twenty percent (20%) as their premium contribution. The employee premium contribution percentage shall remain at the 2024 percentage for 2025 if the City's insurance premium costs do not increase or increase by less than one percent (1%). (Ord. 93-20, 102-20, 14-23)



ORDINANCE NO. 23-23
