MEDINA CITY COUNCIL Monday, June 12, 2023

Public Hearing.

To consider an amendment to the contract establishing and governing the City of Medina-Montville Township Joint Economic Development District pursuant to Ohio Revised Code Section 715.72(L) to add certain property to the district.

Mrs. Marshall spoke in support and stated this is to amend the JEDD contract by bringing in property to the district that they refer to as their Expansion District Area. The property address to be added is 5827 Wooster Pike Road and is for the South Town Center LLC retail project. There was not a clear record of whether that property owner had the opportunity to agree to be part of the JEDD Expansion District. This Public Hearing is out of an abundance of caution to give a 30-day notice. This will be for a retail development that will consist of three standalone buildings.

No one spoke in opposition. Public Hearing closed at 7:34 p.m.

Kimberly Marshall, Economic Development Director, spoke on behalf of Andrew Dutton the Community Development Director announcing the Meijer Retail Development for the former Kmart building had to go through site plan review and the project was approved unanimously. Part of their plans are to apply to demolish the former Kmart building this winter and then break ground in the spring. This should bring about 300 new jobs to the city.

Joe Toth, LST Director, stated that through the month of May the Life Support Team went on 1,444 ambulance calls for the City of Medina and for all three entities a total of 2,166 calls.

Jansen Wehrley, Parks and Recreation Director, stated they kicked off their Party in the Park series which is an eight-week series free to the community and sponsored by the Cleveland Clinic Medina Hospital. Touch A Truck is at the rec center tomorrow and there are 350 children signed up.

Summer camp has begun, it is a 10-week series and there are still spots available.

Reminder to rec members that the indoor pools are closed through August 11th. Memorial outdoor pool is open from 11 a.m. to 8 p.m. Greenwood splash pad is open 11 a.m. to 8 p.m. Seven days a week rain or shine. Ray Mellert splash pads are open from 12 p.m. – 8 p.m.

Patrick Patton, City Engineer, stated they were awarded both ODOT Municipal Bridge funds for the replacement of Prospect St. bridge and South Huntington St. bridge. This comes to a little over \$3.5 million dollars in total for both bridges. This will cover 100% of construction costs. The city will be responsible for design and development costs for both projects.

Introduction and consideration of ordinances and resolutions.

Motion to suspend the Rules requiring three readings on the following ordinances and resolutions: Ord. 99-23, Ord. 100-23, Ord. 101-23, Ord. 102-23, Res. 103-23, Ord. 104-23. Mr. Shields moved, seconded by Mr. Simpson. The roll was called and passed by the yea votes of B. Lamb, P. Rose, J. Shields, D. Simpson, J. Coyne, R. Haire and J. Hazeltine.

Ord. 99-23

An Ordinance amending Section 505.08 of the codified ordinances of the City of Medina, Ohio relative to Animals and Fowl – Feeding of Animals Prohibited, with the addition of a new Section 505.082. Mr. Shields moved for the adoption of Ordinance/Resolution No. 099-23, seconded by Mr. Simpson. Mr. Lamb stated he and the Law director worked together to come up with the language to help protect people's property and at the same time not make it overly burdensome. This is not to turn neighbor against neighbor. Mr. Lamb is voting against this ordinance. The roll was called and Ordinance/Resolution No. 099-23 passed by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, R. Haire, and J. Hazeltine. B. Lamb cast a nay vote.

Ord. 100-23

An Ordinance amending Section 31.05 of the Salaries and Benefits Code of the City of Medina, Ohio relative to the Police Department Communication Operators. Mr. Shields moved for the adoption of Ordinance/Resolution No. 100-23, seconded by Mr. Simpson. Chief Kinney would like to amend the Salaries and Benefits Code to permit the increase of one communications operator to go from ten full-time communications operators to eleven. The reason is growth of our department and the surrounding departments that we dispatch for. The roll was called and Ordinance/Resolution No. 100-23 passed by the yea votes of J. Shields, D. Simpson, J. Coyne, R. Haire, J. Hazeltine, B. Lamb, and P. Rose.

Ord. 101-23

An Ordinance authorizing the payment to Cleveland Communications, Inc. for the communications radio console upgrade for the Police Department. Rose, and J. Shields.

Ord. 102-23

An Ordinance authorizing the Mayor to execute a Dark Fiber Services Agreement with the Medina County Fiber Network to provide the Medina Police Department Communications Center LIT Fiber Services from Medina Fiber network to Parma. Mr. Shields moved for the adoption of Ordinance/Resolution No. 102-23, seconded by Mr. Simpson. Chief Kinney stated this is the fiber connection from the Medina Police Department to Core of the radio system which is housed in Parma. The roll was called and Ordinance/Resolution No. 102-23 passed by the yea votes of J. Coyne, R. Haire, J. Hazeltine, B. Lamb, P. Rose, J. Shields, and D. Simpson.
