ORDINANCE NO. 99-23

AN ORDINANCE AMENDING SECTION 505.08 OF THE CODIFIED ORDINANCES OF THE CITY OF MEDINA, OHIO RELATIVE TO ANIMALS AND FOWL – FEEDING OF ANIMALS PROHIBITED, WITH THE ADDITION OF A NEW SECTION 505.082.

WHEREAS: That Section 505.08 of the codified ordinances of the City of Medina, Ohio presently reads as follows:

505.08 NUISANCE CONDITIONS PROHIBITED.

- (a) No person shall keep or harbor any animal or fowl in the Municipality so as to create noxious, or offensive odors or unsanitary conditions which are a menace to the health, comfort or safety of the public.
- (b) No person being the owner or in charge or control of any animal shall permit the animal to defecate upon any public or private land other than the land where the owner or person in charge of such animal resides.
- (c) The owner or person in charge or control of any animal which defecates on any such prohibited land shall immediately clean such and cause its removal to a proper receptacle.
- (d) The owner or person in charge of any animal shall keep the property where he resides in a clean and sanitary condition by regularly removing the defectation of his animal to prevent accumulation.
- (e) The accumulation of defecation of any animal is hereby created to be a nuisance condition if it creates an unsanitary or unhealthy condition and is a violation of this section.
- (f) This section shall not apply to any animal which has been expressly invited to enter upon private property by the owner or person in charge of such animal.
- (g) Whoever violates this section is guilty of a minor misdemeanor. (Ord. 138-98. Passed 9-14-98)

505.081 PROHIBITED AREAS.

(EDITOR'S NOTE: Former Section 505.081 was repealed by Ordinance 64-02, passed April 22, 2002.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

SEC. 1: That Section 505.08 of the codified ordinances of the City of Medina, Ohio shall be amended to read as follows pertaining to Feeding of Animals Prohibited:

505.08 NUISANCE CONDITIONS PROHIBITED.

- (a) No person shall keep or harbor any animal or fowl in the Municipality so as to create noxious, or offensive odors or unsanitary conditions which are a menace to the health, comfort or safety of the public.
- (b) No person being the owner or in charge or control of any animal shall permit the animal to defecate upon any public or private land other than the land where the owner or person in

charge of such animal resides.

- (c) The owner or person in charge or control of any animal which defecates on any such prohibited land shall immediately clean such and cause its removal to a proper receptacle.
- (d) The owner or person in charge of any animal shall keep the property where he resides in a clean and sanitary condition by regularly removing the defectaion of his animal to prevent accumulation.
- (e) The accumulation of defecation of any animal is hereby created to be a nuisance condition if it creates an unsanitary or unhealthy condition and is a violation of this section.
- (f) This section shall not apply to any animal which has been expressly invited to enter upon private property by the owner or person in charge of such animal.
- (g) Whoever violates this section is guilty of a minor misdemeanor. (Ord. 138-98. Passed 9-14-98)

505.081 PROHIBITED AREAS.

(EDITOR'S NOTE: Former Section 505.081 was repealed by Ordinance 64-02, passed April 22, 2002.

505.082 FEEDING OF ANIMALS PROHIBITED.

- (a) No person shall purposely or knowingly provide food for deer, geese, ducks, raccoons, fowl or other wild animals, wildlife or stray animals, except as otherwise specifically authorized in designated and marked public areas, where such feeding:
 - (1) Causes or contributes to damage to the property of another; or
 - (2) Creates a public or private nuisance.
- (b) This section does not apply to fishing, feeding of animals owned by that person or to song birds fed from a stationary and off-ground/hanging bird feeder.
- (c) This section shall not apply to a law enforcement officer, game officer or conservation officer enforcing the laws of the State of Ohio, or any local ordinances, nor to anyone officially authorized by the City to engage in an animal control program, including, without limitation, a feral cat Trap-Neuter-Vaccinate-Return Program or similar program.
- (d) The City may initiate a civil action in the Court of Common Pleas for injunctive and other relief for any violation of this section.
- (e) Whoever violates this section is guilty of a minor misdemeanor for a first offense and a misdemeanor of the fourth degree for each subsequent offense. A separate offense shall be deemed committed on each day on or during which a violation of this section occurs.
- SEC. 2: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.

Reference Master Service Agreement December, 2017

FIBER CONSTRUCTION AND OSP ENTRANCE SERVICES

WHEREAS, the City of Medina desires to engage the services of the Medina County Fiber Network (MCFN) for the construction of an outside plant (OSP) fiber optic lateral entrance; and

NOW THEREFORE, in consideration of the mutual covenants and Agreements hereinafter set forth in this Lit Fiber Services Agreement, the PARTIES agree as follows:

- 1. **DEFINITIONS** As used in this Agreement, the following terms have meaning given to them below:
 - 1.1. Path Engineering Path engineering involves walking the fiber routes to survey poles, railroad crossings, and bridge under/over passes. This process is to ensure that the fiber path chosen can be physically built on the structures available. During this process all available poles will surveyed and recorded, any underground spans are measured for distance and public utilities are noted, and any obstructions are surveyed and recorded. After this process all information should be gathered for the permitting process.
 - 1.2. **Permits** Involves filing all the appropriate paperwork with the various facility providers for access to poles and utility right of ways.
 - 1.3. Materials Includes cables, hardware and equipment.
 - 1.4. **Construction Preparation** Includes make ready on utility poles, right away agreements for undergrounds spans and closing any issues with materials needed to construct the infrastructure. Also includes a final review of all construction plans and maps along with filings.
 - 1.5. **Construction** Physical fiber infrastructure is placed on the utility poles and/or buried underground. This process will involve interaction with construction project managers and outside plant crews.
 - 1.6. **Site Preparation** Site surveys will need to be performed on all locations to determine available space, power, and environmental requirements. Involves pre-site installation work that is required to bring the site to operational status.
 - 1.7. Site Constructions Includes any site entrances and cabling required connecting outside plant into the physical space.
 - 1.8. **Equipment Installation** Installation of equipment and hardware to support the network infrastructure. This includes physically installing the equipment at the Physical customer locations. Includes all items needed to attach the customer premise to the network infrastructure.
 - 1.9. **Turn-Up and testing** OTDR testing of all lateral fibers on the implemented network span. Provisioning connectivity from the customer premise to the appropriate gateway and enabling contracted services.
 - 1.10. **Network Certification** Includes certification from MCEDC and the customer that the services are active and delivered per the contract.

2. CONSTRUCTION STANDARDS

- 2.1 Review the design and develop a project plan for fiber implementation.
- 2.2 Review all drawings of proposed routes and identify any potential conflicts.
- 2.3 Meet-Me Pole, Manhole and Mid-Span Interconnection Splicing plans include splicing into the fibers at locations as defined in the network design documentation. Order of splicing is existing splice cases, followed by existing slack coils.
- 2.4 Provide materials for the project, including fiber optic cabling, splice closures, fold back shoes, stranding, conduit, and all necessary hardware for aerial and underground construction.
- 2.5 Install conduit and/or pull fiber optic cable underground via plowing or boring, as per the route design specifications.
- 2.6 Comply with all local and state regulations with respect to traffic management while installing fiber optic cable.
- 2.7 All contractors participating in fiber optic build services will be registered in the appropriate city.
- 2.8 Install, terminate and splice the number of fibers stated in the service addendum.
- 2.9 Testing with OTDR.



3. BUILD REQUIREMENTS & QUALITY

- 3.1. The latest revision of the National Electrical Safety Code and the National Electrical Code shall be followed unless local codes are more stringent, in which case local codes will be followed.
- 3.2. Final network acceptance will include a live on-line operation of the network.
- 3.3. Materials containing asbestos shall not be used in the cable construction.
- 3.4. All hardware is of Industry Standard.
- 3.5. All grounds will be returned to original conditions after construction is complete.
- 3.6. Only fusion splicing is used.
- 3.7. All terminations will be LC connectors unless otherwise noted
- 3.8. A composite single mode cable will be used.
- 3.9. Guys shall be placed where necessary per Industry Standards.
- 3.10. Anchor assembly units shall be placed per Industry Standards.
- 3.11. All strand wire will be Industry Standard 6M or 10M type as required.
- 3.12. Suspension strand will be grounded at all poles that have existing grounds.
- 3.13. Cable guards shall be applied over the cable at points of potential abrasion such as at supports and in locations where tree trimming is not permitted
- 3.14. Cable will be double lashed.

4. TESTING

- 4.1. Fiber optic cable will be tested for conformance to the referenced ICEA and EIA specifications prior to installation.
- 4.2. Each cable will be tested after installation with an OTDR @ 1310 and 1550 nm.

5. SAFETY

5.1. Construction services observe and comply with all applicable federal, state and local safety rules and regulations including, without limitation, the Occupational Safety and Health Act ("OSHA"). All construction equipment utilized in the installation of fiber optics is operated only by licensed operators.

6. PROPERTY RIGHTS

6.1. All materials used in the construction of the fiber optic lateral and in operation of the fiber network for transport services are the sole property of MCFN.

7. FIBER PATH

7.1 The fiber path will be constructed in accordance with the diagram shown in Exhibit 1.

8. RIGHT OF ENTRY

8.1. The Subscriber permits the MCFN and/or its agents to enter upon our property for the purpose of installing an underground fiber cable in conduit. It will be the responsibility of the MCFN and/or its agents to repair and/or replace any fences or structures damaged during the construction period, and/or restore turf lying within the working limits to its original condition with seed.


