Res. 107-25

A Resolution authorizing an application for grant assistance from the Medina County Drug Abuse Commission (MCDAC) for funding to support the Medina Police Department School Resource Officer Program. Mr. Shields moved for the adoption of Ordinance/Resolution No. 107-25, seconded by Mr. Simpson. Chief Kinney explained this supports their School Resource Officers as well as the County Drug Task Force. The roll was called and Ordinance/Resolution No. 107-25 passed by the yea votes of P. Rose, J. Shields, C. Simmons, D. Simpson, J. Coyne, N. DiSalvo, and R. Haire.

Ord. 108-25

An Ordinance amending Ordinance No. 76-25, passed April 28, 2025, relative to the purchase of a dump body from Henderson Products, Inc. for the Street Department. Mr. Shields moved for the adoption of Ordinance/Resolution No. 108-25, seconded by Mr. Simpson. Nino explained this is to cover the freight charge of \$1,147.00 and need to amend the ordinance by \$1,500.00. The roll was called and Ordinance/Resolution No. 108-25 passed by the yea votes of J. Shields, C. Simmons, D. Simpson, J. Coyne, N. DiSalvo, R. Haire and P. Rose.

Ord. 109-25

An Ordinance authorizing the increase of the expenditure to Wintrow Construction Corporation for the Engineering Department. Mr. Shields moved for the adoption of Ordinance/Resolution No. 109-25, seconded by Mr. Simpson. Patrick explained that they have experienced a rash of emergency rail line breaks and repairs this year. This ordinance will cover the cost of the emergency repairs to date and includes \$14,600 for future 2025 repairs. Ord. 111-25

An Ordinance authorizing the Finance Director to make certain fund advances.

Mr. Shields moved for the adoption of Ordinance/Resolution No. 111-25, seconded by Mr. Simpson. Keith explained one is a grant project, and 2 for bond anticipation notes for the court project. Ord. 112-25

An Ordinance authorizing the Finance Director to make certain fund transfers.

Keith stated the Cable TV fund used to be self-supporting on the amount of money that we brought in from the cable franchise fee but as that has fallen off and this is a transfer of money that came back from RITA on reconciliation. The roll was called and Ordinance/Resolution No. 112-25 passed by the yea votes of N. DiSalvo, R. Haire, P. Rose, J. Shields, C. Simmons, D. Simpson, and J. Coyne.

Res. 113-25

A Resolution authorizing the filing of an application for grant assistance with the Ohio Rail Development Commission (ORDC). Mr. Shields moved for the adoption of Ordinance/Resolution No. 113-25, seconded by Mr. Simpson. Patrick stated they located a grant that they think would apply to their railroad to replace 1,500 linear feet of rail. This is am 80/20 grant, if successful he would have to do a transfer to cover the city portion of cost. The roll was called and Ordinance/Resolution No. 113-25 passed by the yea votes of R. Haire, P. Rose, J. Shields, C. Simmons, D. Simpson, J. Coyne, and N. DiSalvo.

Ord. 114-25

An Ordinance authorizing the Mayor to enter into a Partnership Agreement between Medina County, Ohio and the Cities of Brunswick, Medina and Wadsworth to file an application for grant assistance with the Ohio Department of Development (ODOD) for a PY2025 Community Housing Impact and Preservation Program (CHIP) Grant. Mr. Shields moved for the adoption of Ordinance/Resolution No. 114-25, seconded by Mr. Simpson. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 114-25, seconded by Mr. Simpson. Barb Dzur stated they are partnering with the County as with Brunswick, and Wadsworth for a CHIP Grant. This will bring in more money for the county. Emergency clause is needed as the grant is due. An Ordinance authorizing an expenditure to Medina City Schools for renovations of the Medina Community Recreation Center's main locker rooms. Mr. Wehrley explained this project consists of demo and installation of new tile flooring, shower and restroom partitions in the locker rooms at the rec center. The roll was called and Ordinance/Resolution No. 116-25 passed by the yea votes of J. Coyne, N. DiSalvo, R. Haire, P. Rose, J. Shields, C. Simmons and D. Simpson.

Mr. Simpson commented to remember to be kind to one another.
