#### Ord. 134-22:

An Ordinance authorizing the Mayor to execute a Purchase Agreement for approximately 30.05 acres of land located at 2000 Medina Road, Medina, Ohio; Medina County Permanent Parcel Number 033-12A-03-017 for Medina Municipal Airport expansion and operations. Mr. Shields moved for the adoption of Ordinance/Resolution No. 134-22, seconded by Mr. Simpson. Mr. Huber suggested making the passage of this ordinance subject to his approval so that he can work on some of the changes in the contract that were discussed. Greg stated this ordinance authorizes the Mayor to sign a contract for purchase of 30 acres of land immediately adjacent to the east side of the Medina Airport for a cost of \$550,000.00. The FAA has been favorably responsive to grant applications that will be made to reimburse the City of Medina for 95% of the cost of this purchase. Our engineers that handle the airport operations have examined this land and determined that it is excellent for future expansion of the airport and would allow a better aircraft parking facility, better maintenance facility and corporate hangers. Our airport is considered by almost all the pilots that he has known and people that have used the airport has an excellent feeder facility between Akron / Canton and Cleveland Hopkins it has great approaches from all directions and has good potential to be more self-sufficient if we can achieve this expansion and ultimately expand the runway to 4,000 feet so that we meet insurance minimums for more corporate aircraft. There is a lot of indirect economic benefit from our airport at this time. It can be a lot better if we are able to expand to some extent and hopefully this works well. The roll was called subject to Law Director's approval and Ordinance/Resolution No. 134-22 passed by the yea votes of J. Coyne, R. Haire, J. Hazeltine, B. Lamb, P. Rose, J. Shields, and D. Simpson.

It is specific to Officer Wellness, Recruitment, Retention and Resiliency. If awarded the intent is to remodel the workout room downstairs. The grant is for \$142,011.00 there is no match and this has no impact on the City ARPA Funds. Emergency clause is requested as the grant was due last month. Mayor Hanwell stated this is another mechanism for the city to try and bring some outside money to help support our Medina TV operations like we are doing with the Medina County Commissioners, this is an agreement to do some film work and editing for Mainstreet Medina Events for them to use for promotions and for their website and the request for the emergency clause is so that it can get started sooner and not have the summer go by without the opportunity to gather some of those events since it is their busiest time of the year. The roll was called on adding the emergency clause and was approved by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, R. Haire, J. Hazeltine. B. Lamb cast a nay vote. A Resolution authorizing the Mayor to execute an Economic Development (TREX) Transfer form from the Division of Liquor Control for the property located at 220 N. State Street. Mr. Shields moved for the adoption of Ordinance/Resolution No. 138-22, seconded by Mr. Simpson.

Mrs. Marshall stated this is for Pickleback LLC located at 220 North State Street, they have identified a liquor permit that they are requesting to be transferred into the City of Medina. The seller of the liquor license is Sweet Carrot Grandview LLC. Pickleback will initially employ 10 to 12 people and generate income tax for the City of Medina as well as an investment in an underutilized building. Asking for the emergency clause because their attorney Mark Meyers has located a seller and would like to execute a final purchase agreement on the deal and get it finalized as soon as possible. The roll was called on adding the emergency clause and was approved by the yea votes of D. Simpson, J. Coyne, R. Haire, J. Hazeltine, B. Lamb, P. Rose, and J. Shields. An Ordinance authorizing the Mayor to advertise for competitive bids and to award a contract to the successful bidder for the West Smith Reconstruction, Phase 4 project. Mr. Shields moved for the adoption of Ordinance/Resolution No. 139-22, seconded by Mr. Simpson. Mr. Patton stated this will be the fourth and final phase of the reconstruction on West Smith Road. Starts east of State Road and continues to South Court Street. Estimated cost is \$5,096,000.00. \$2,046,590.00 of that is being provided via federal grant. An Ordinance authorizing the increase of the expenditure to Wintrow Construction Corporation for the emergency repairs to the City Railway. AN ORDINANCE DECLARING THE NECESSITY TO APPROPRIATE A PERMANENT STANDARD HIGHWAY EASEMENT ON A PROPERTY AS SET FORTH IN EXHIBIT "A" FOR THE REPLACEMENT OF THE GATES MILLS BOULEVARD CULVERT, AND DECLARING AN EMERGENCY.

- WHEREAS: It has been determined that it is necessary for the City of Medina to acquire a permanent easement from a property owner whose property is listed by permanent parcel number on Exhibit "A," attached hereto and incorporated herein, for the purpose of removing and replacing the Gates Mills Boulevard culvert;
- **WHEREAS:** The Law Director for the City of Medina has been unable to satisfactorily negotiate the acquisition of the permanent easement with the property owners listed on Exhibit "A";
- WHEREAS: In order that the culvert to be replaced within a reasonable time and for the avoidance of inconvenience to the residents of the City of Medina, it is necessary to obtain the permanent easement in the most expeditious manner possible.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- SEC, 1: That a permanent easement in and to the property known as Permanent Parcel Number 028-19D-05-280, more fully described in Exhibits "A" attached hereto and incorporated herein, is hereby appropriated pursuant to the State of Ohio Constitution, laws of the State of Ohio, and the ordinances of the City of Medina, Ohio.


