1. <u>Assignment of Requests for Council Action</u>

2. 25-172-8/25 – Medina Meow Fix Funding Request

The request is again for \$5,000. SPCA is willing to administer again with requirements.10% goes to SPCA for administrative duties.

Mr. Shields moved to approve \$5,000 with the SPCA administering funds, seconded by Mr. Simpson. Motion passed 6-0.

3. <u>25-174-9/8 – Budget Amendments</u>

- a. #2025-033 Chief Walters thanked the Park Foundation for generous donation. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.
- b. #2025-034 \$100 donation for Police Department. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.
- c. #2025-035 Pass through revenue sharing from the ice cream vending. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.

4. 25-175-9/8 – Task Order #2 – Delta Airport Consultants

Patrick stated the update will be \$13,500 and will be reimbursed at 95% through future FAA grant. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.

5. <u>25-176-9/8 – Accept Easements for Prospect Street Bridge</u>

Need four total easements and 2 have been approved, these are the other two. Emergency is needed for recording of easements. \$632.00 total. Mr. Shields moved to approve with the emergency, seconded by Mr. Simpson. Motion passed 6-0.

Jansen spoke of the universal changing station and this donation for one in the Rec Center. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.

7. 25-178-9/8 – RFP's – Drug Screen & Related Professional Services

Mayor Hanwell stated this is our annual request for proposals. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.

- 8. 25-179-9/8 Purchase two (2) Pick-Up Trucks Street Dept.
- The new vehicles are a 2025 F-150 and 2026 F-250 4x4. Nino Piccoli explained this is to replace a 2010 GMC and a 2011 pickup to go to auction. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.
- 9. <u>25-180-9/8 Increase P.O. #2025-338 Dynamerican Public Bldgs</u>.

Nino stated that Dynamerican has done significant work specifically in the Police Dept. replacing 4 toilets. At this time, we need to increase the P.O. by \$5,000 in order to get us through some other plumbing issues that may be unforeseen to get us through the rest of the year. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.
