 Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.
- 3. <u>24-224-11/12 Rollover Outstanding Advances</u> Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.
- 4. <u>24-225-11/12 Budget Amendments</u>
 - a. 2024-054 Keith Dirham stated this is a pretty extensive adjustment but it is to cover all these advances that were just passed with the last two RCA's. Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.
 - b. 2024-056 Jansen stated this is revenue from ice cream sales at Fred Greenwood Park. Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.
 - c. 2024-057 Kimberly Marshall stated they partnered with Main Street, Community Design Committee, Chamber of Commerce and Convention and Visitor Bureau and these are contributions from them to help offset the cost of the printing for visitor guide. Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.
- 5. <u>24-226-11/12 Dispatch & Communications Service Agreement w/ Medina Hospital Life Support Team</u>
- Lt. Scott Marcum stated this is a 3-year renewal contract that provides dispatch services to the Life Support. Scott stated they pay 33% of the total operational cost of the dispatch center. Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.
- 6. <u>24-227-11/12 Dispatch & Communications Service Agreement w/ Medina Twp.</u>
 Lt. Marcum stated this is also a 3-year renewal for dispatch services that we provide Medina Twp. at a cost of \$78,000.00 a year they pay the City of Medina. Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.
- 7. <u>24-228-11/12 Dispatch & Communications Service Agreement w/ Montville Twp.</u>
 Lt. Marcum explained this is also a 3-year renewal for dispatch services that Medina City provides for Montville Twp. at a cost of \$78,000.00 a year. Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.

8. <u>24-229-11/12 – RFP/RFQ – Permitting & Code Enforcement Software – Community Development Dept.</u>

Andrew Dutton stated this new software is proposed as the current software does not offer online permits, middle or adequate storage amongst other things. Mr. Simpson moved to approve, seconded by Mr. Rose. Motion passed 6-0.
