ORDINANCE NO. 111-24

AN ORDINANCE AUTHORIZING THE MAYOR TO ACCEPT THE MODIFICATIONS TO THE MEDINA COUNTY THOROUGHFARE PLAN PROPOSED PROJECT LIST AS RECOMMENDED BY THE MEDINA AREA TRANSPORTATION TASK FORCE.

- **WHEREAS:** In 2001, the Medina Area Transportation Task Force comprised of individuals from the four adjacent townships, County government, business and the City was formed by the City to evaluate the possible solutions to the congestion problems in the area; and
- **WHEREAS:** The Task Force was charged with making long-term and short-term recommendations dealing with problems associated with traffic flow and safety in the general area of the City; and
- WHEREAS: The Medina Area Transportation Task Force presented their Final Report in December, 2001 and was adopted by Ord. 107-02, passed June 24, 2002; and
- WHEREAS: The Medina Area Transportation Task Force reconvened on April 2, 2024 and determined that due to residential development since the implementation of the Medina County Thoroughfare Plan in 2002, modifications of the Plan Project List at the Southern Corridor were in order; and
- **WHEREAS:** The Medina Area Transportation Task Force met on May 7, 2024, and by unanimous vote, recommended the following modifications to the Plan Project List at the Southern Corridor:
