ORDINANCE NO. 158-25

AN ORDINANCE VACATING A PORTION OF REAL ESTATE ON EAST WASHINGTON STREET TO THE BISHOP OF THE CLEVELAND DIOCESE.

- WHEREAS: Ordinance No. 138-87, passed December 14, 1987 vacated a portion of real estate on East Washington Street and accepted a Dedication Plat of real estate on East Washington Street for street and all other utility purposes; and
- WHEREAS: St. Francis Xavier Church has requested that the 0.1408 acre right-of-way be vacated and transferred back to the church as "The Bishop of the Cleveland Diocese"; and
- **WHEREAS:** The Planning Commission reviewed this request and unanimously recommended approval of the request at their regular meeting on August 14, 2025.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- **SEC. 1:** That the portion of East Washington Street as shown on Exhibit A, attached hereto and incorporated herein, is hereby vacated.
- SEC. 2: That the Vacation Plat, vacating the 25 ft. wide right-of-way, part of Outlot 2 in original Medina Township Lot 79, shall be signed and recorded with the Medina County Recorder's Office.
- SEC. 3: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.
- **SEC. 4:** That this Ordinance shall be in full force and effect at the earliest period allowed by law.
