- SEC. 4: That this Resolution shall be considered an emergency measure necessary for the immediate preservation of the public peace, health and safety, and for the further reason that the rates must be certified to the County Auditor before October 29, 2021; wherefore, this Resolution shall be in full force and effect immediately upon its passage and signature by the Mayor.
