

ORDINANCE NO. 111-22

AN ORDINANCE AMENDING SECTIONS 31.02(B)(1) AND 31.05 OF THE SALARIES AND BENEFITS CODE OF THE CITY OF MEDINA, OHIO RELATIVE TO THE CEMETERY LABORER POSITION, AND DECLARING AN EMERGENCY.

WHEREAS: Section 31.02 (B) (1) of the Salaries and Benefits Code pertaining to the Parks and Recreation Department, Cemetery Laborer position presently reads as follows:

SEC. 1: That Section 31.02 (B) (1) of the Salaries and Benefits Code of the City of Medina, Ohio shall be amended in part to read as follows relative to the Parks and Recreation Department:
