ORDINANCE NO. 112-22

AN ORDINANCE AMENDING AND REPLACING SECTION 31.02(E) OF THE SALARIES AND BENEFITS CODE OF THE CITY OF MEDINA, OHIO RELATIVE TO THE MEDINA COMMUNITY RECREATION CENTER PART-TIME PAY SCALE, ABOLISHING THE POSITIONS OF TOUR GUIDE, CAFÉ ATTENDANT AND CAFÉ SUPERVISOR, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- SEC. 1: That Section 31.02(E) of the Salaries and Benefits Code of the City of Medina pertaining to the Medina Community Recreation Center Part Time Pay Scale is hereby amended.
- SEC. 2: That a copy of the "old" current pay scale is marked Exhibit A and the "new" amended pay scale is marked Exhibit B, attached hereto and incorporated herein, and will become effective beginning June 5, 2022.
- SEC. 3: That the positions of Tour Guide, Café Attendant and Café Supervisor are hereby abolished.
- That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.
- SEC. 5: That this Ordinance shall be considered an emergency measure necessary for the immediate preservation of the public peace, health and safety, and to begin advertising for vacant positions to fill current vacancies; wherefore, this Ordinance shall be in full force and effect immediately upon its passage and signature by the Mayor.
